ARTICLE I: NAME.

The name of the Corporation is:

CNR ENTERPRISES, CORP.

ARTICLE II: DURATION.

The Corporation shall exist in perpetuity

ARTICLE III: PURPOSE.

The Corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV: CAPITAL STOCK.

The Corporation is authorized to issue 400 shares of \$ 10.00 par value common stock which shall be designated "Common Shares".

ARTICLE V: PRE-EMPTIVE RIGHTS.

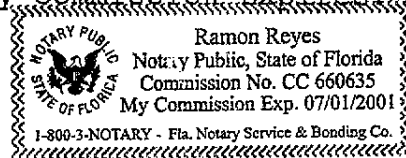
