ARTICLE IV

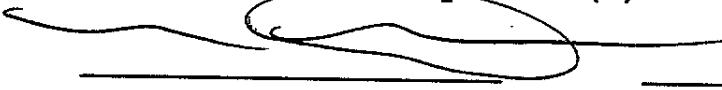
Incorporator
