ARTICLE I

A special meeting of all the stockholders of the Corporation was called by the Board of Directors pursuant to Florida Statutes Section 607.1003 for the purpose of considering an amendment to the Articles of Incorporation to change the name of the Corporation to SENIOR LIVING OPTIONS OF FLORIDA, INC.
