ARTICLES OF INCORPORATION

THE UNDERSIGNED, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE I

NAME

The name of this corporation is biweeklyhomesavings.com, inc.

DURATION

The Corporation shall have perpetual existence.



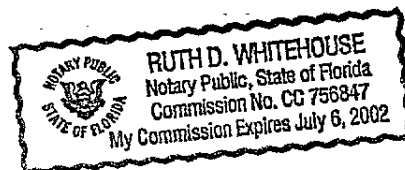
