Gentlemen:

I just received a notice that I had not filed the 2001 Uniform Business Report which was due by May 1, 2001, also indicating that a \$400 penalty is now due along with the form by Sept 12, 2001.

This was an oversight on my part--since my new lawn business was just completing it's first year (established May 1, 2000; fiscal year-end Dec 31), I had met with my accountant in January '01 to prepare the first year's tax return. By April, he had not yet worked on my return, and had asked me to gather all business information together again for his review. Unfortunately, I had included this form in the information and therefore overlooked it as I waited for the tax return to be prepared (he ended up filing for an extension).

As this penalty would create a hardship on the operation of my business, I am pleading for the penalty to be forgiven in light of the circumstances described above as well as the fact that this is the first filing of this form for my business. I am enclosing the original form along with the \$150.00 which was due by May 1st, in hopes that the penalty will be forgiven. However, I understand that I may still owe the penalty and will pay it if I must.

Please contact me as soon as possible if it is determined that I must pay the \$400 penalty so that I can take care of it before September 12th. Thank you.
