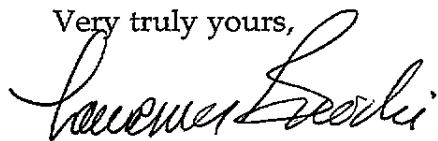

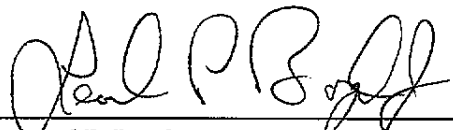

1. The name of this Corporation is BFG II, INC. (the "Corporation").
2. The street address of the initial principal office and mailing address of the Corporation is 1918 Port St. Lucie Boulevard, Port St. Lucie, Florida 34952.
3. The total number of shares of all classes of stock which the Corporation shall have the authority to issue is 10,000,000, consisting of (i) 5,000,000 shares of Class A Common Stock, par value \$.001 per share, and (ii) 5,000,000 shares of Class B Common Stock, par value \$.001 per share. Except as specifically required by law, the Class A shares are non-voting shares and the Class B shares are voting shares in all matters; in all other respects, Class A and Class B shares are equal and are to be treated identically.
4. The name and street address of the registered agent of the Corporation is Lawrence P. Brodie, 525 Camden Avenue, Stuart, FL 34994.
