ARTICLES OF INCORPORATION OF L. K. CLEANING SERVICES, INC.

ARTICLE L NAME

The name of this corporation shall be:

L. K. CLEANING SERVICES, INC.



ARTICLE I. COMMENCEMENT & DURATION

The commencement of this corporation's existence shall be at the time of the filling of these Articles Of Incorporation by the State of Fiorida, Department of State, Division of Corporations.

This corporation's duration shall be perpetual.

ARTICLE II. PURPOSE

This corporation is being organized for the purpose of completing all aspects of cleaning services and shall engage in the transaction of any and all business activities permitted under the laws of Florida and the United States Of America.


