The undersigned subscriber who is of legal age and competent to contract for the purposes of forming a corporation under the laws of the State of Florida, hereby adopts and acknowledges the following Articles of Incorporation for this Corporation.

**ARTICLE I**

The name of this Corporation shall be:

**ARTICLE II**

The general nature of the business and the objects and purposes proposed to be transacted and carried on are medical facility development and building to the extent as natural persons might or could do and specifically the Corporation may engage in any activity or business permitted under the laws of the United States of America and/or the State of Florida.

### ARTICLE III




