The undersigned Incorporators for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation shall be: CENTRAL FLORIDA CERTIFIED AUTO REPAIR, INC..

ARTICLE II - PRINCIPAL OFFICE

The place of business and mailing address of this corporation shall be: 7330 Edgewater Drive, Orlando, Florida, 32810.

ARTICLE III - EXISTENCE

This corporation shall exist perpetually, unless dissolved according to law.

ARTICLE IV - NATURE OF BUSINESS
