**CERTIFICATE OF INCORPORATION  
OF**

**INTERNATIONAL SHIP OPERATORS, CORP.**

We, the undersigned, do hereby associate ourselves and subscribe this Certificate of \_\_\_\_\_  
Incorporation for the purpose of forming a corporation under the laws of the State of Florida, and  
subject to the following provisions:

**ARTICLE ONE**

The name of the corporation shall be **INTERNATIONAL SHIP OPERATORS, CORP.**

**ARTICLE TWO**

The corporation may engage in any activity or business permitted under the laws of the United  
States and of the State of Florida.

**ARTICLE THREE**

The maximum number of shares of stock which the corporation shall have outstanding at any  
time, shall be 500 shares of stock which shall be common stock of \$1.00 par value per share. All or  
any part of the capital stock may be paid for either in lawful monies of the United States of America,  
or in services, at a true valuation thereof.

**ARTICLE FOUR**

This Corporation shall begin business with a minimum capital of the amount of Five Hundred  
(\$500.00) dollars.

**ARTICLE FIVE**

This Corporation shall have perpetual existence.

**ARTICLE SIX**

Initially the principal office of the corporation shall be located at 2215 N.W. 14<sup>th</sup> Street,

Miami, Miami-Dade County, Florida, 33125; other offices for the transaction of business may be located wherever the Directors may deem necessary or expedient.

#### **ARTICLE SEVEN**

The business of the corporation shall be managed by a Board of Directors, who need not be stockholders of the corporation. Originally there will be two directors. The number of Directors, not less than one, shall be fixed by resolution of the stockholders at any regular or special meeting, subject to the manner of holding such meetings prescribed by the by-laws.

This corporation shall have full power to carry on and transact each or all of the businesses

enumerated in Article Two of this Certificate, and shall have all the general and additional powers now and hereafter conferred upon it by law.

#### ARTICLE ELEVEN

This corporation shall have the power to issue the whole or any part, determined by the Board of Directors, of the shares of the capital stock as partly paid, subject to calls thereon until the whole thereof shall have been paid.


#### ARTICLE TWELVE

Upon election of a Board of Directors by the stockholders such Board of Directors shall manage the business affairs of this corporation without the necessity of further authority from the stockholders, except as by law or in this certificate otherwise provided by the by-laws of the Board of Directors. All holders of common stock of this corporation shall be entitled to vote the same in the manner provided by law whether said stock shall be fully or partially paid unless otherwise determined by the Board of Directors at or before the time of issuance thereof.

#### ARTICLE THIRTEEN


