**ARTICLES OF INCORPORATION**

- Article I: The name of the corporation shall be Brooks Business Partners Inc.
- Article II: The principal office of the Corporation shall be located at 6821 S.W. 12<sup>th</sup> Street, Pembroke Pines, Florida 33023.
- Article III: Duration of the Corporation shall be perpetual.
- Article IV: The purpose for which the Corporation is organized and shall be operated is to render services to other corporations, business and individuals. To offer any other services authorized by law. To offer any products or services for resale.
- Article V: The Corporation is empowered:
- (a) To buy, own, sell, assign, mortgage or lease any interest in real or personal property for such periods as may be authorized by law and to hold, manage, mortgage and sublease the same;

Article IX: These Articles of Incorporation may be revoked or amended by majority vote of the Corporation stockholders.

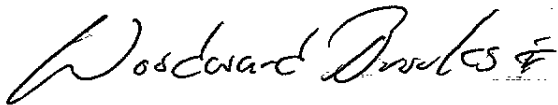
