<u>ARTICLE I - NAME</u>

The name of the corporation is COCOS BAR & GRILL, INC.

<u>ARTICLE III - NATURE OF BUSINESS</u>

The purpose of the business is to engage in any activities or business permitted under the laws of the United States and the State of Florida.


ARTICLE IX - AMENDMENT
