

ARTICLES OF INCORPORATION
OF
NAPIER'S PROFESSIONAL LAWN SERVICE AND
PRESSURE CLEANING, INC.

The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, adopt the following Articles of Incorporation:

ARTICLE I
NAME

The name of the corporation is NAPIER'S PROFESSIONAL LAWN SERVICE AND PRESSURE CLEANING, INC.

ARTICLE II
PRINCIPAL PLACE

The street address of the initial principal office of the corporation is 411 West 30th Street, Riviera Beach, Florida 33404.

ARTICLE III
EXISTENCE

This corporation shall commence existence upon the filing of these Articles of Incorporation by the Department of the State, State of Florida; and shall have perpetual existence.

ARTICLE IV
PURPOSES

The general purposes for which the corporation is organized are:

1. To provide professional lawn services and pressure cleaning to customers.

2. To transact any other lawful business for which corporations may be incorporated under the Florida Business Corporation Act or engage in any other trade or business which can, in the opinion of the Board of Directors of the Corporation, be advantageously carried on in connection with or auxiliary to the

proceeding business.

3. To do such other things as are incidental to the above or necessary or desirable in order to accomplish the above.

ARTICLE V **CAPITALIZATION**

The aggregate number of shares which the corporation is authorized to issue is one (1000) thousand. Such shares shall be of a single class, and shall have a par value of one (\$1.00) dollar per share, unless otherwise stated in these Articles, or any Amendment to these Articles. There shall be one (1) class of stock of this corporation, common stock.

ARTICLE VI **REGISTERED OFFICE AND AGENT**






