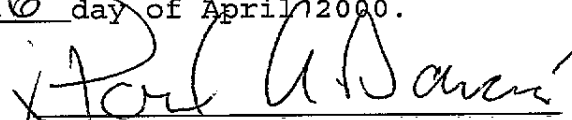
**ARTICLE VI - TERM OF EXISTENCE**

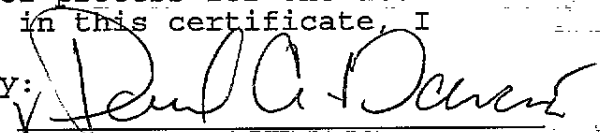
