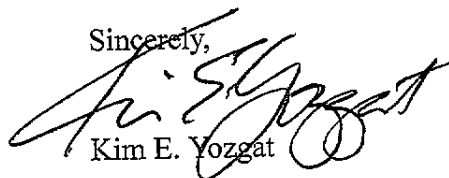

The undersigned hereby notifies all people of the State of Florida that he intends to form a corporation for profit in accordance with Chapter 607, Florida Statutes, and hereby adopts the following Articles of Incorporation for such corporation:

**ARTICLE I – NAME, MAILING ADDRESS AND PRINCIPAL OFFICE**

The name of this corporation shall be the **Great Southern Investments & Asset Management Corporation**. The mailing address shall be 3600 NW 43<sup>RD</sup> Street, Suite C-1, Gainesville, Florida 32606, and the principal office shall be located at 3600 NW 43<sup>RD</sup> Street, Suite C-1, Gainesville, Florida 32606.

**ARTICLE II - TERM**

This corporation shall have perpetual existence unless sooner dissolved according to law. This corporation shall begin business on the day of the filing of these Articles of Incorporation with the Secretary of State.

**ARTICLE III - PURPOSE**

This corporation is organized for the purpose of transacting any or all lawful business, including, but not limited to, the following:

- (a) To do any and all acts and things, and to exercise any and all other powers conferred by the laws of Florida upon corporations formed under the provisions of Chapter 607, Florida Statutes, and which now or hereafter may be authorized by law; and
- (b) To have and exercise all powers necessary or convenient to effect its purposes.

#### **ARTICLE IV - STOCK**

The maximum number of shares of stock outstanding at any time shall be 10,000,000 with no par value per share, all of which shall be common stock.

#### **ARTICLE V - PREEMPTIVE RIGHTS**

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class, or series as that which he or she already holds, shall have the right to purchase his or her pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which such stock is offered to others.
