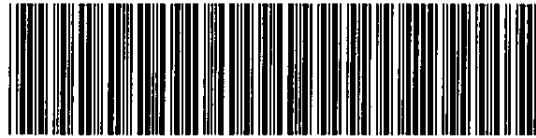

**ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF
NORTH AMERICAN TITLE INSURANCE GROUP, INC.
(Name Change)**

WHEREAS, the Articles of Incorporation of North American Title Insurance Group, Inc. (the "Corporation") were filed with and approved by the Secretary of State of Florida on the 1st day of May, 2000 [Doc. P00000044178]; and

WHEREAS, it is the intention of a majority of the directors of the Corporation and a majority of the shareholders of the Corporation entitled to vote, that the Articles of Incorporation be amended in accordance with the proposed amendments set forth herein; and

WHEREAS, the proposed amendment to the Articles of Incorporation hereinafter set forth were approved by a consent of a majority of the directors of the Corporation and a majority of the shareholders of the Corporation, entitled to vote, said majority being sufficient for approval, pursuant to the revisions of Section 607.0821 and 607.0704, Florida Statutes, by a Written Statement Manifesting Director and Stockholder Approval of Amendments to the Articles of Incorporation dated the 7th day of May, 2007, and there are no other voting groups entitled to vote on the amendments; and
