The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation.

ARTICLE I
NAME AND ADDRESS

Section 1.1 Name. The name of the corporation is Dowden & Associates, Inc.

Section 1.2 Address of Principal Office. The address of the principal office of the corporation is 4005 Buckskin Trail East, Jacksonville, Florida 32277.

Section 1.3 Mailing Address. The mailing address of the corporation is 4005 Buckskin Trail East, Jacksonville, Florida 32277.

ARTICLE II
DURATION

Section 2.1 Duration. This corporation shall exist perpetually. Corporate existence shall commence on the date these Articles are executed, except that if they are not filed by the Department of State of Florida within five business days after they are executed, corporate existence shall commence upon filing by the Department of State.

PURPOSES
