ARTICLE I. NAME

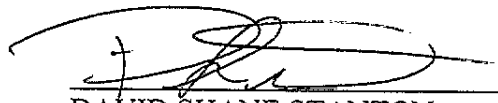
ARTICLE VII. INCORPORATOR

ARTICLE VIII. AMENDMENT

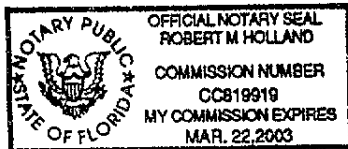

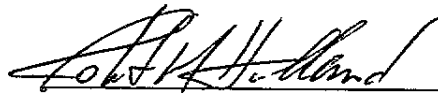
