ARTICLE I

Name

The name of the corporation is ORLANDO TRUCK CENTRE, INC.

ARTICLE II

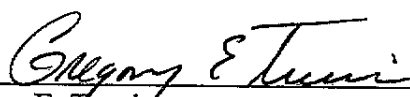
