

#### ARTICLE XI, SUB CHAPTER S CORPORATION


This corporation may be a Sub-Chapter S Corporation as defined by the Internal Revenue Code.



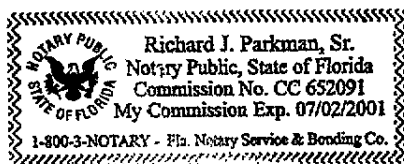
