OF

This corporation may engage in the transaction of any and all lawful business for which corporations may be incorporated under Florida Law.

Articles III

This corporation shall have perpetual existence.

Articles IV

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 1,000 shares of common stock, each having a \$1.00 par value.

The corporation will not commence until it has received for the issuance of shares, consideration of the value of \$200 consisting of money, labor done or property actually received.

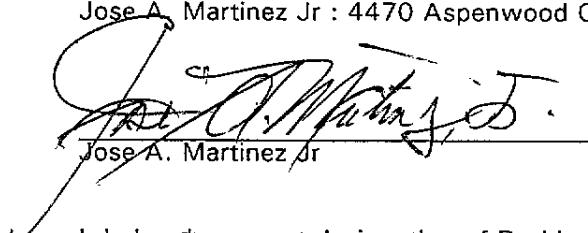

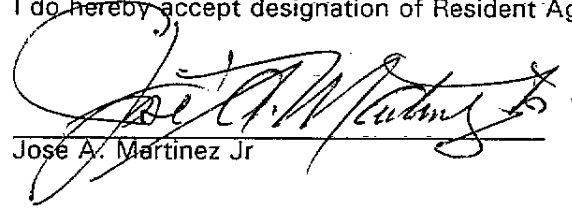
