With great surprise we received by mail your "notice of Administrative Dissolution or Revocation" because so far this year we have never received any letters, bills, etc. from you and suddenly we are notified that we are currently inactive and pay a high fee in order to reactivate our corporation.

We are a small corporation, established on May 2000 and we open to the public on August 18, 2001. Since then we are providing employment to 12 persons, still are in the way to reach a financial break even point (as you may see on the attached financial statement) and our Florida Sales taxes have been paid always on time. Because we are almost new in these corporation aspects and our learning curve is still in the initial stage, this year 2002 we assumed that because we were paying monthly & on time Florida sale taxes our corporation was active and thus never worried about not receiving any news from you. But yesterday over the phone one of your representatives informed us that independently from your Florida sales tax responsibility you must activate every year with the Florida Department of state your corporation.

Actually we are applying for an SBA loan in order to expand our operations with the purpose of putting to work our underutilized production capabilities (currently running at 25% of their capacity), reach financial stability and generate more jobs specially now when our country needs them.
