# ARTICLES OF INCORPORATION OF ROBISON & GRAMLICH, P.A.

#### ARTICLE I. NAME

The name of this Corporation is ROBISON & GRAMLICH, P.A. The mailing address of the Corporation is 1201 Fifth Avenue, North, St. Petersburg, Florida 33705.

## ARTICLE II. TERM OF EXISTENCE

This Corporation shall have perpetual existence commencing upon the filing of these Articles with the Florida Secretary of State.

## ARTICLE III: PURPOSE

The general nature of the business to be transacted by this Corporation is health care and to engage in every phase and aspect of the business of rendering the professional services to the public that a physician duly licensed under the laws of the State of Florida, is authorized to render, but such professional services shall be rendered only through officers, employees and agents of this corporation who are duly licensed under the laws of the State of Florida to perform said services.

- SECTION 4.4 To lend money to and use its credit to assist its officers and employees to the full extent permitted by law.
- SECTION 4.5 To purchase, take, receive, subscribe for, or otherwise acquire, own, hold, vote, use, employ, sell, mortgage,

lend, pledge, or otherwise dispose of, and otherwise use and deal in and with, shares or other interests in, or obligations of, other domestic or foreign corporations, associations, partnerships or individuals, or direct or indirect obligations of the United States or any other government, state, territory, governmental district, or municipality or of any instrumentality thereof.

- SECTION 4.6 To make contracts and guaranties and incur liabilities, borrow money at such rates of interest as the Corporation may determine, issue its notes, bonds, and other obligations, and secure any of its assets.
- **SECTION 4.7** To lend money for its corporate purposes, invest and reinvest its funds, and take and hold real and personal property as security for the payment of funds so loaned or invested.


