I have discovered another situation with regard to this client's corporate records and have attached backup information from their files. As the 2007 annual renewal was filed along with, I'm sure several thousand others from around the State of Florida during the last week of April 2007, I believe this may have been inadvertently missed!

Thomas J. Bean is listed as the owner, officer, registered agent for a number of entities within the State of Florida. The 2007 annual reports were filed, including the one above, returned to the Division at the end of April for these entities (see list below). As I was pulling the 'face page' for each for update of the corporate records books and to add to their verification files on each, I noted this one was missing. Accordingly, I verified with the client that the report had been filed and attach that backup for your review including a QuickBooks Check Detail printout that reflects the check number that was sent - #5479 in the amount of \$150.00 (please note that #5477 was mistakenly made out to the Division of Corporations and was VOIDed with the correct payee listed on #5479 - Florida Department of State). Additionally attached are copies of the Bank of America account statement for periods ending April 30, 2007 and May 31, 2007. The April 30 statement ends at check #5478 reflecting a gap between #s5475 and 5478 which would account for the VOID check of 5477; the May 30 statement reflects a gap between #s5476 and 5480 - accounting for the VOID check of 5477 and the unpresented check of 5479. As of last Friday, June 29, 2007, check number 5479 still had not been presented for payment.

I have listed below all of the other renewals which were sent at the same time for respective entities and all of which were entered by the Division on May 2, 2007 which makes us think that Digiquest Technologies, Inc. was just inadvertently missed:
