#### ARTICLES OF INCORPORATION

OF

### CHACHA GETDOWN, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

### ARTICLE I. NAME

The name of the corporation shall be: Chacha Getdown, Inc. The principal place of business of this corporation shall be 3643 S. Westshore Blvd., Tampa, Florida 33629.

### ARTICLE II. NATURE OF BUSINESS
