WE, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation for profit under the laws of the State of Florida, and do here by certify that we have Become such a corporation under and pursuant to the following Articles of Incorporation.

# ARTICLE I.

The name of this corporation is WILLIAMS CONSTRUCTION OF LAKELAND, INC., hereinafter referred to as the Corporation.

#### ARTICLE II.

The general nature of the business and objects and purposes to be transacted, promoted or carried on are to do any and all of the things hrereinafter mentioned, as fully and to the same extent as natural persons might or could do, viz:

- 1. To act as a general contractor for the construction, repairing and remodeling of buildings and public works of all kinds, and for the improvement of real estate, and the doing of any and all other business and contracting incidental thereto, or connected therewith, and the doing and performing all and any acts or things necessary, proper, or convinent for or incidental to the furtherance or the carrying out of the powers or purposes herein mentioned.
  - 2. To buy, sell, acquire, hold, own and dispose of real property.
- To borrow money and contract debts when necessary for the transaction of
   Its business or for the exercise of its corporate rights.
- 4. To do all and everything necessary and proper for the accomplishment of any of the purposes or the attainment of any of the objects or the furtherance of any of the powers enumerated in this Certificate of Incorporation or any amendment thereof, necessary or incidental to the protection and benefit of the corporation, as principal, agent, director, trustee

or otherwise, and in general, either alone or in association with other corporations, firms or individuals, to carry on any lawful business necessary or incidental to the accomplishment of the purpose or the attainment of the corporation, whether or not such business is similar in nature to the purposes and objects set forth in this Certificate of Incorporation or any amendment thereof.

### ARTICLE 111.

The maximum number of shares which this corporation shall be authorized to issue and have outstanding at one time shall initially be limited to one hundred (100) shares of common stock, all which shall have a par value of one hundred dollars (\$100.00) per share.

### ARTICLE 1V.

The amount of capital stock with wich the corporation shall begin business shall be Ten
Thousand Dollars (\$10,000.00)

#### ARTICLE V.

The corporation shall have perpetual existence.

#### ARTICLE VI.

The principal place of business of said corporation is 3823 Eric Court, Lakeland, Florida 33813, with the privilege of having branch offices or places of business at any other place or places within or without the State of Florida.

#### ARTICLE V11.

This corporation shall have from two to four director's initally. The number of directors may be increased or diminished from time to time, by by-laws adopted by the stockholders, but shall never be less than two.
