

ARTICLES OF INCORPORATION OF THE BANK OF COMMERCE

The undersigned, acting as the incorporators of The Bank of Commerce (the "Corporation") under the Florida Business Corporation Act, adopt the following Articles of Incorporation.

ARTICLE I

Corporate Name and Principal Office

The name of the Corporation shall be The Bank of Commerce and its initial place of business shall be 783 South Orange Avenue, Sarasota, Sarasota County, Florida 34236.

ARTICLE II

General Nature of Business

The general nature of the business to be transacted by the Corporation shall be that of a commercial banking business with all rights, powers and privileges granted and conferred by the Florida Financial Institutions Codes, relating to the organization, powers and management of banking corporations.

ARTICLE III

Capital Stock

The number of shares authorized to be issued by the Corporation shall be 2,000,000. Such shares shall be of a single class and each shall have a par value of \$5.00. The Corporation shall begin business with at least \$4,250,000 of paid-in capital, to be derived from the issuance of 850,000 shares, as well as initial capital surplus of not less than \$2,975,000 and undivided profits of not less than \$1,025,000, all of which (capital stock, surplus, and undivided profits) shall be paid in cash.

ARTICLE IV

Term of Existence

The term for which the Corporation shall exist shall be perpetual unless terminated pursuant to the Florida Financial Institutions Codes.

ARTICLE V

Incorporators and Initial Directors

The names and street addresses of the incorporators of the Corporation, who shall also serve as the Corporation's initial directors, are set forth below:
