**ARTICLES OF INCORPORATION  
OF

I, the undersigned, make subscribe, acknowledge and file with the Secretary of State of the State of Florida these Articles of Incorporation for the purpose of forming a professional services corporation for profit in accordance with the laws of the State of Florida.

**ARTICLE I - NAME**

The name of the corporation shall be **MOHAMMAD A. SHUAYB, DMD, P.A.** and the corporate mailing address shall be **12900 Cortez Boulevard, Suite 201, Brooksville, Florida, 34613-7808.**

**ARTICLE II - NATURE OF BUSINESS AND POWERS**

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida, including but not limited to the providing of medical professional dental services and other services commonly performed as an incident thereto.

**ARTICLE III - CAPITAL STOCK**

The amount of capital stock authorized shall consist of **one thousand (1,000)** shares of common voting stock having a par value of **\$ - 0 -** per share payable in lawful money of the United States of America or in other property, tangible or intangible, but not in labor services or stock, at a just valuation to be fixed by the Board of Directors, or issued as partly paid when so ordered by the Board of Directors. The capital stock of the corporation may at any time be increased or decreased as provided by the laws of Florida.

**ARTICLE IV - PREEMPTIVE RIGHTS**

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without the issuance of fractional shares) at the price at which is offered to others.

**ARTICLE V - TERM OF EXISTENCE**

This corporation shall have perpetual existence unless sooner dissolved according to law, commencing upon the filing of these Articles of Incorporation with the Department of State, State of Florida.

This Corporation shall have **one (1)** director initially. The number of directors may be increased or diminished from time to time by Bylaws adopted by the stockholders, but shall never be less than one.

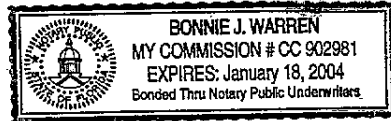




