ARTICLE ONE

The name of the corporation is **J & S CONTRACTORS OF BOCA, INC.** The principal address of the corporation is: 10470 Sleepy Brook Way, Boca Raton, FL 33428

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE THREE

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act.
