The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the Corporation shall be:

The principal place of business of this Corporation shall be 3104 Avenue F NW, Winter Haven, FL 33880.

ARTICLE II. NATURE OF BUSINESS
