ARTICLES OF INCORPORATION

of

Avant Garde Engineering, Inc.

The undersigned Incorporator for the purpose of forming a corporation under Chapter 607 Florida Statutes, hereby adopts the following Articles of Incorporation:

ARTICLE I- NAME AND ADDRESS

The name of this corporation is *Avant Garde Engineering, Inc.* The business mailing address of the corporation is 121910 Hale Rd., Land O' Lakes, Florida 34639.

ARTICLE II - DURATION

The duration of the corporation is perpetual.

ARTICLE III - SHARES OF STOCK

The aggregate number of shares which the corporation is authorized to issue is One Thousand (1,000). Such shares shall be of a single class and shall have a par value of One Dollar (\$1.00) per share.

ARTICLE IV - PURPOSE

ARTICLE VIII - AMENDMENTS

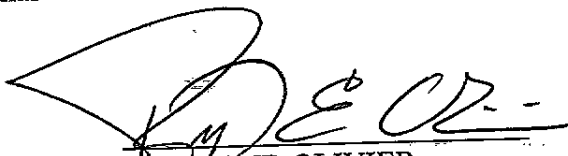
The Articles of Incorporation of the corporation may be amended by resolution of the Board of Directors, approved by the members of the corporation, as provided in the Bylaws of the corporation.

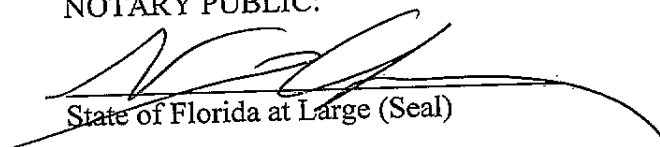

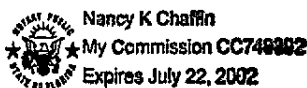
