One thousand (1,000) common voting shares with a par value of One dollar (\$1.00) each.

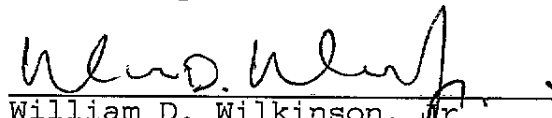
