### ARTICLES OF INCORPORATION

OF

### PLANET COMMUNICATIONS.COM, INC.



The undersigned, for the purpose of forming a corporation under the provisions of Chapter 607 of the *Florida Statutes*, hereinafter referred to as the Corporation, hereby agrees to the following:

#### ARTICLE I Name and Address

The name of the Corporation shall be **PLANET COMMUNICATIONS.COM**, **INC.** and its mailing address is 12600 South Belcher Road, Suite 104B, Largo, Florida 33773.

### ARTICLE II Purpose and Powers

Section 1. The Corporation is formed for the purpose of engaging in any lawful activity or business for which corporations may be incorporated under the laws of the State of Florida.

Section 2. The Corporation may exercise all powers, rights and privileges conferred on corporations pursuant to the laws of the State of Florida.

#### ARTICLE III Term of Existence
