The undersigned, acting as Incorporator for the purpose of forming a for profit Corporation under the provisions of Chapter 607 of the Florida Statutes, hereby delivers the following Articles of Incorporation for said Corporation to the Department of State of the State of Florida.

ARTICLE I: NAME

The name of the Corporation is Courthouse Services, Inc. The address for the principal office of this corporation shall be 200 S.E. 6TH Street, Fort Lauderdale, Florida 33301.

ARTICLE II: PURPOSE

The name and address of the Incorporator executing these Articles of Incorporation is: Matthew Destry, 200 SE 6th, Fort Lauderdale, Florida 33301.


ARTICLE VI: TERM OF EXISTENCE
