Article I - Name and Address

Article II - Duration

This corporation shall exist perpetually.

Article III - Purpose and Powers

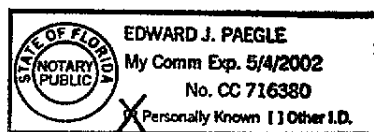
