**ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporator of VALORES BAVARIA INTERNET INC. under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is VALORES BAVARIA INTERNET INC.

ARTICLE II. ADDRESS

ARTICLE III. COMMENCEMENT OF EXISTENCE


ARTICLE VIII. BYLAWS
