**ARTICLES OF INCORPORATION**

**THE UNDERSIGNED**, acting as incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation for such corporation.

**ARTICLE I**

The name of the corporation shall be: MZV ENTERPRISES INC.

**ARTICLE II**

The principal place of business and mailing address of this corporation shall be:

**ARTICLE III**

The Corporation shall have the authority to issue 5,000 shares of common stock, all of one class, at one dollar par value.

**ARTICLE IV**

The shareholders shall have the preemptive rights to purchase, at prices, terms and conditions that shall be fixed by the Board of Directors, such shares of stock as may be issued from time to time, in addition to that stock authorized and issued by the corporation. The preemptive right of any holder is determined by the ratio of the authorized and issued shares of the common stock held by the holder of common stock currently authorized and issued.


**ARTICLE VIII**




