The undersigned Incorporator hereby forms a corporation under the laws of the State of Florida:

**Article I. Corporate Name.**

The name of this Corporation is:

**Article III. Capital Stock.**

The aggregate number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is One Million (1,000,000) shares of common stock having a par value of \$.001 per share. **Article VIII. Amendment.**

Except as may otherwise be provided in the Bylaws of this Corporation, this Corporation shall indemnify its incorporators, officers and directors to the fullest extent permitted by law either now or hereafter in effect.
