ARTICLE I.

NAME

The name of this corporation is **Linuxville.net, Inc.**

ARTICLE II.

PRINCIPAL OFFICE

The principal office and mailing address of this corporation is: **5801 Imperial Key, Tampa, Florida 33615.**

ARTICLE III.

DURATION: EFFECTIVE DATE

This corporation shall exist perpetually, commencing as of the date of filing with the Secretary of State.

ARTICLE IV.

PURPOSES

This corporation may engage in any activity or business permitted under the laws of the United States of America and of this State.

ARTICLE V.
CAPITAL STOCK

This corporation is authorized to issue **Ten Thousand (10,000)** shares of **One Dollar (\$1.00)** par value common stock.
