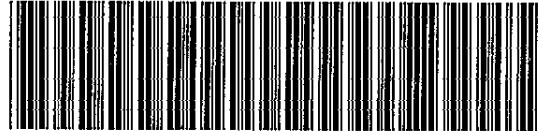

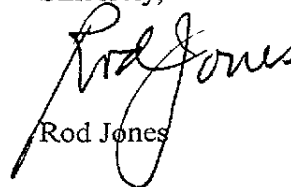

Pursuant to the provisions of section 607.1003(6), Florida Statutes, NELSON'S MOBILE HOME PARK, INC., a Florida corporation, adopts the following Articles of Amendment to its Articles of Incorporation:

**FIRST:**

Article I of the Articles of Incorporation of NELSON'S MOBILE HOME PARK, INC., is hereby amended to read:

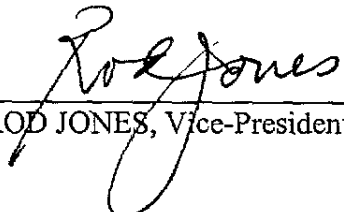
ARTICLE I
