ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is LollyPops & Lace, Inc.

ARTICLE II - PRINCIPAL OFFICE

The mailing address of this corporation shall be: 2900 Oslo Avenue Cooper City, Florida 33026

ARTICLE III - PURPOSE
