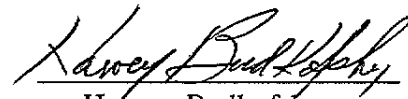

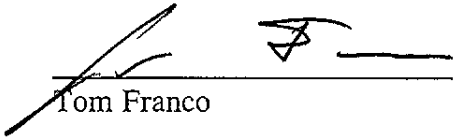
- FIRST: The name of this Corporation is Energyworld Futures Corporation.
