Articles of Incorporation  
of

I, the undersigned, hereby make, subscribe, acknowledge and file with the Secretary of State of The State of Florida these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

ARTICLE I

Name

The name of this corporation shall be **TROPICAL VIEWS, INC.**

ARTICLE II

Principal Place of Business/Mailing Address

The principal place of business of the corporation is not yet known. The mailing address for the corporation is 597A Corey Ave., St Pete Beach, FL 33706.

ARTICLE III

Duration

The corporation shall begin existence as of the date of filing and shall exist perpetually.

ARTICLE IV

Purpose

The purpose of this corporation is to transact any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes.




