ARTICLES OF INCORPORATION OF

The undersigned acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

I. The name of the corporation is FAT CAT VENTURES, INC.

II. The period of its duration is perpetual.

III. The purpose of the corporation is to engage in any activities or business permitted under the laws of the United States, the State of Florida and in such other states as the corporation shall be authorized to do business.

IV. The aggregate number of shares which the corporation shall have authority to issue is 1,000 shares, all of one class, and having no par value.

V. The street address of its registered office, which is also the street address of the principal place of business of the corporation is 90K WIND TREE LANE, and the name of its registered agent at 90K Wind Tree Lane Winter Garden, FL 34787 is William Thomas Dutton, who is a resident of this State.

VI. The affairs of this corporation shall be directed by the stockholders.

VII. This corporation may operate with one (1) person holding all offices of the corporation and performing all duties of each office. There shall be a President, such Vice Presidents as are necessary, one Secretary and one Treasurer.
