## ARTICLES of INCORPORATION of RAILROAD MACHINERY TRADERS, Inc.

TALEGE MAY AND STATE

The undersigned incorporators under these Articles of Incorporation order to form a corporation under the laws of Florida, hereby certify:

ARTICLE 1 - The name of the corporation is:

ARTICLE 2 - This corporation is to exist perpetually.

ARTICLE 3 - The general purposes for which this corporation is organized is:

- (a) To manufacture, assemble, build, repair, lease, purchase or otherwise acquire, sell, exchange, dispose of, deal or traffic in, distribute and exhibit railroad machinery, engines, carriers, cars, equipment, parts and accessories of every class and description, instruments, components, devices, supplies and accessories in connection therewith; to operate railroad stations, manufacturing plants, passenger, cargo, mail and express lines; to service and maintain railroad machinery, engines, cars, and components, to engage in railroad manufacturing, repairs, and sales of said work; to operate railroad machinery businesses, and all components thereof, both at retail and at wholesale, as principal or agent.
- (b) To engage in the business of, railroad transportation, railroad machinery, transportation of passengers or cargo, freight forwarding movement of cargo; furnishing every kind of support service to railroads, including, but not limited to administration, office personnel, cargo handling, railroad maintenance, ticket handling, cargo and passenger ticket sales and promotion, import and export documentation and services, custom documentation and any other service in connection with the railroad business, both passenger and cargo, both at wholesale or retail, as principal or agent, and any other business in connection therewith.
- (c) To do anything which a corporation may lawfully do under the laws of the State of Florida.
- ARTICLE 4- The street and mailing address of the initial principal office of the corporation is: 9650 S.W. 122<sup>nd</sup> Court, Miami, Florida 33186.
- ARTICLE 5- The aggregate number of shares of stock which the corporation shall have authority to issue is 50 shares of no par value, capital stock.
