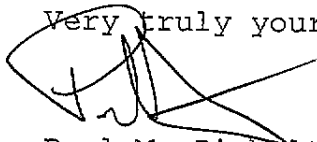

**FIRST:** The name of the corporation is:

**SECOND:** The purpose of the corporation is to engage in any lawful act or activity for which corporations may be organized under the corporate laws of the State of Florida.
