Pursuant to the provisions of §607.1402 and §607.1403, Florida Statutes, the undersigned corporation adopts the following Articles of Dissolution of the purpose of dissolving the corporation.

1. The name of the corporation is ROORKEE SYSTEMS, INC.
2. Dissolution of the corporation was authorized by written consent of a majority of the shareholders pursuant to §607.0704 and §607.1402, Florida Statutes, on 1/19, 2002.
3. One hundred percent (100%) of the shares outstanding and entitled to vote on the matter of dissolution, voted for dissolution. No voting by class is required, and the foregoing vote is sufficient for approval of dissolution.
