Dear Dr. Korn,

I had the pleasure of seeing Sime Stantic at the Rush Heart Institute recently. As you recall he has pulmonary hypertension of uncertain etiology and chronic dyspnea. A new symptom since I saw him last, on April 3, 2001, is chest pressure with activity which I feel represented classic effort angina.

CT scan results were dramatically positive, and showed the presence of coronary atherosclerosis in all of his coronary arteries.


Consequently he underwent successful angioplasty and stenting with no residual stenosis.

I am hopeful that the angioplasty will relieve his chest tightness symptoms. In follow-up to that, his medication needs to be adjusted.

I would restart his Coumadin and watch it carefully, shooting for an INR of 2.0-2.5 times control. In addition I told Sime to double his dose of Lipitor to 20 mg, and would suggest that you continue to watch his lipid response to it.

We asked Sime to call us frequently to keep us posted as to how he is doing. If you have any questions at all regarding his day-to-day care, please feel free to call us any time.
