
The undersigned, of the age of eighteen years or over, for the purpose of forming a corporation pursuant to the provisions of Section 607.164 of the Florida Statutes does hereby execute the following Articles of Incorporation.

- First: The name of the corporation is HTC ESCROW SERVICES, INC.


