ARTICLES OF INCORPORATION OF DigiLaw Publishing, Inc.

The undersigned incorporator to these Articles for Incorporation hereby form a corporation under the laws of the State of Florida as follows:

ARTICLE I

Name and Address

The name of this Corporation DigiLaw Publishing, Inc. The street address of the Corporation is: 2451 McMullen Booth Road, Clearwater, Florida 33759.

ARTICLE II

Term of Existence

This Corporation shall have perpetual existence, commencing upon filing of these articles of incorporation with the Florida Secretary of State.
